ADMISSION POLICY

B Tech Admissions

Admission is strictly on the basis of merit. 50% of the total seats in B. Tech. Courses are set apart for centralized allotment by the Commissioner for Entrance Examinations.

15% of seats within sanctioned intake is provided for NRI Category and given on the basis of marks obtained for Physics, Chemistry and Mathematics in 12th Standard. For the management merit seats, the rank list is prepared on basis of index marks obtained by combining the percentage marks of Mathematics, Physics and Chemistry at the Plus Two level and/or the percentage score obtained in the Kerala Engineering Entrance Examination or any recognised entrance examination for this purpose. The marks obtained in the State Board/CBSE/ICSE for each subject are normalized with reference to the highest marks obtained by applicants from the respective Board

Merit List for admission will be prepared and selection will be in the order of Merit through Counselling. Individual intimation with the date and time for counselling will be sent to all successful applicants through email. The counselling can be in online or offline mode.

No intermediaries are involved in our admission process. Admissions are through direct application in online mode for management seats and Government seats are allotted by the Controller of Entrance Examinations, Kerala.

Admission Procedure – Government Allotment

For getting allotment through Government Quota the students have to go through the centralized allotment process and enter their options in the Institution Code MGP on the date specified by the Commissioner of Entrance Examination.

Fee Structure

Saintgits College of Engineering (Autonomous) has a uniform fee structure for Management and Government seats.

ELIGIBILITY

Eligibility for Management Allotment Admission

Candidates who have passed Higher Secondary Examination, Kerala, or Examinations recognized as equivalent thereto, with Physics and Mathematics as compulsory subjects and Chemistry as one of the optional subjects with at least 45% marks put together in the above subjects are eligible for Management Quota Admission. A valid KEAM rank (or any other approved entrance examination rank as permitted by Govt of Kerala) is mandatory for admission to Management Seat.

Eligibility for NRI/PIO Allotment Admissions

- Candidates who have passed Higher Secondary Examination, Kerala, or Examinations recognized as equivalent thereto, with 50% marks in Mathematics separately and 50% marks in Physics, Chemistry and Mathematics (PCM), put together are eligible for NRI Quota admission. However excellent marks for PCM in the qualifying examination are desirable.
- KEAM (Kerala Entrance Exam) rank is not mandatory to apply under this quota.
- This quota is for applicants sponsored by NRIs/PIOs and/or children of Indians employed in Gulf Countries. An NRI can sponsor the children or dependents and he/she will have to give an undertaking in the prescribed format. Also, he/she should provide a copy of his/her Passport and a copy of the VISA, all self-attested.

Eligibility for Government Allotment Admissions

- Eligibility for admission to the B. Tech. the programme, admission policy and procedure shall be decided from time to time by following the guidelines issued by the Government of Kerala, the Government of India and other statutory bodies such as AICTE.
- Admission to B. Tech. shall be based on the guidelines given by the State and Central Governments on the reservation. Candidates for admission to the B. Tech. the programme shall have passed the Higher Secondary Examination, Kerala or 12th Standard, T. H. S. E., V. H. S. E., C. B. S. E., I. S. C. or any other examination considered equivalent to the above-mentioned ones. Other eligibility criteria for admission is currently prescribed by the Government of Kerala through Government orders which are based on the entrance examination conducted by the Commission for Entrance Examinations, Government of Kerala and the marks in the qualifying examination subject to the relaxations allowed for backward classes and other communities as specified from time to time.
- Candidates who have passed Higher Secondary Examination, Kerala, or Examinations recognized as equivalent thereto, with Physics and Mathematics as compulsory subjects and Chemistry as one of the optional subjects with at least 45% marks put together in the above subjects are eligible for Govt allotment.
- A valid KEAM rank is mandatory and seat allotment is based on the KEAM rank and order of preference.

Scholarships

The AICTE-approved Tuition Fee Waiver Scheme is implemented in the college. Accordingly, students with high academic results and hailing from economically backward families are granted full tuition fee concession. 5% of seats of the total intake will be filled under Tuition Fee Waiver Scheme over and above the sanctioned intake. The above seats will be filled up by the allotment of the Commissioner for Entrance Examinations.

In addition, the Management offers Saintgits Merit Scholarships for meritorious students based on their 12th score and/or financial background. Details of various scholarships are published on the Admissions page of the college website.

MCA and Integrated MCA Admissions

How to Apply

The application can be submitted only through online mode in the portal available on the College website (www.saintgits.org). The candidates, who successfully complete the online application, will automatically receive an acknowledgement via email and SMS.

MCA Eligibility

- The eligibility criteria/norms prescribed by AICTE, DTE and Higher Education Department, Government of Kerala stipulates that;
- Candidates should have passed any graduation degree (e.g.: B.E./B.Tech./ B.Sc/B.Com./ B.A./ B. Voc./ etc.,) preferably with Mathematics at 10+2 level or at Graduation level
- Candidates should have obtained at least 50 % marks in the Degree examination. It is 45 % in the case of candidates belonging to reserved category.
- Candidates belonging to Socially and Educationally Backward Classes (SEBC) referred to GO(P)208/66/Edn dated 2-5-96 and subsequent amendments to order issued by the Government shall be given a relaxation of 2% marks.

- A relaxation of 5% marks from the prescribed minimum shall be allowed in the case of physically handicapped persons.
- Candidates who have passed the qualifying examination in more than one chance in the subject (excluding languages) will have their percentage marks derated by 5% for every additional appearance for the purpose of ranking. Reservation of seats shall be as per rules prescribed in the relevant rules by the Directorate of Technical Education, Government of Kerala.

Integrated MCA Eligibility

Passed 10+2 examination with Mathematics OR Statistics OR Accountancy as compulsory subjects. Obtained at least 45% marks (40% marks in case of candidates belonging to reserved category) in 10+2 examination.

Procedure of Selection

The admissions shall be based on the ranks obtained in the entrance examination rank list conducted by LBS and marks obtained for the qualifying examination. The seats will be allotted by the college based on merit and strictly following the reservation policy of the Government, provided there are sufficient applications from that category. LBS rank is not mandatory for students admitted under the NRI category. Candidates are advised to visit the website of the college and appear for an interview and admission as notified therein.

MBA Admissions

A high CAT/CMAT/KMAT/other approved test score is the basis for entry to the Department of Business Administration (SAINTGITS Institute of Management). To be eligible, you should have passed any bachelor degree examination from a recognized university with not less than 50% marks in aggregate in all parts of the examination. Based on your score in approved tests, you will be invited for an interaction at SAINTGITS Institute of Management. You will be given an opportunity to showcase your prowess in group discussion followed by a personal interview. We give due weightage for work experience

It is mandatory that students need to clear any one of the entrance examinations namely the Common Admission Test (CAT) conducted by IIMS, the Common Management Admission Test (CMAT) conducted by AICTE, or the Kerala Management Aptitude Test (KMAT) conducted by the Commissioner of Entrance Examination, Government of Kerala.

- Electives offered: *Marketing, Human Resource Management, Operations, Corporate Finance, Accounting and Control, Banking and Financial Services, Systems, Business Analytics and General Management.
- Intake: 120 Seats (Two Batches)

M. Tech. Admission

Criteria of Eligibility for M. Tech. Admission

- a) The candidate shall be an Indian national.
- b) The candidate should have studied the undergraduate course in an institution approved by the AICTE / Deemed Universities.

c) Candidates should have a minimum of 60% aggregate marks in the appropriate branch of Engineering Degree Examinations or equivalent. For SC/ST candidates a pass in the Engineering Degree course is sufficient.

1. For Machine Design: B.Tech / BE Degree in Mechanical Engg. / Automobile Engg. / Production Engg. & Mechatronics Engg.

2. For Geomechanics & Structures: B.Tech / BE Degree in Civil Engg.

3. Structural Engineering / Construction Mgt: B.Tech / BE Degree in Civil Engg.

4. For Power Systems: B.Tech / BE degree in Electrical & Electronics Engg.

5. For VLSI & Embedded Systems B.Tech/BE degree in Electronics & Comm. Engineering / Applied Electronics & Instrumentation Engg. /Appl. Electronics Engg/Electronics & Inst. Engg. / Electronics & Bio Medical Engg. / Inst. Egg. /Electronics Engg. / EEE.

6. For Telecommunication Engg.: B.Tech/BE degree in Electronics Engineering/Applied Electronics & Instrumentation Engg.

7. For Computer Science & System Engineering : B.Tech / BE Degree in Computer Science &Engg/IT

8. For Robotics & Automation Engg.:B.Tech/BE degree in Mechanical Engg. / Electrical Engg. / Electronics Engineering/Applied Electronics & Instrumentation Engg./Inst.& Ctrl. Engg./ Prod.Engg./Automobile Engg./Ind.Engg/ Manufacturing Technology.

(d) Candidates who have passed AMIE examination and satisfying the following conditions are eligible for admission.

1. They must have valid GATE score.

2. A minimum marks of 55% for the section B in AMIE / AMIETE examination.

3. Minimum 3 years of professional experience in the field of specialization after acquiring the ualifying degree.

(e.) Candidates who have appeared for the final semester examination can also apply, provided he / she has passed all the subjects up to and including the 6th semester exam. Such candidates shall submit self-attested copies of all mark lists showing marks of individual subjects up to 6th semester along with the application. Selection of such candidates shall be subjected to the production of qualifying degree- satisfying clauses 3.(a) to (d) as applicable on or before 27 August 2022

(f.) Admission shall normally be restricted to those with valid GATE score. However, this stipulation is relaxed in the case of sponsored candidates.

(g.) In case seats remain vacant due to lack of candidates with valid GATE score, candidates from Kerala State without valid GATE score will be considered against such vacancies and if seats are still remaining vacant, candidates from other states will be considered for admission.

(h.) Candidates who have passed qualifying examinations from other Universities / Institutions (non KTU) should produce eligibility certificate from Kerala Technological University as well as Migration Certificate at the time of admission. Students from the universities outside Kerala have to obtain Recognition Certificate from KTU after getting allotment .

How to Apply

Online application can be submitted in the portal available on the College website (www.saintgits.org). The candidates, who successfully complete the online application, will automatically receive an acknowledgment via email and SMS.

e. Copies of following Certificates/Documents (self attested) should be submitted along with the application.

1. SSLC or equivalent certificate in proof of the Date of Birth.

2. Mark list of the qualifying examination (BE/B.Tech).

3. Copy of GATE SCORE CARD should be attached for the consideration of GATE score. Disqualified student should also attach the same for the purpose of preparing the Management Rank list.

4. DTE Rank.

In case of candidates claiming any sort of reservation or special consideration, documents to prove such claims must be submitted along with the application.

f. Applications not accompanied by documents in proof of claims of reservation will not be considered in such categories. Documents/certificates furnished after the last date of submission of the application will not be entertained under any circumstances. Late and incomplete applications will be rejected.

Procedure for Selection

a) Candidate must register their names online in the website of Director Technical Education, Trivandrum (www.dte_kerala.gov.in) from 17 August 2022. DTE will prepare a rank list by considering the candidates' GATE score / aggregate marks obtained up to 6th semester in the qualifying degree examination. Candidates qualified in ranking by DTE can submit applications to Saintgits before the date notified in the college website. Saintgits will publish a merit list based on the ranking by DTE, in which 50% of seats will be filled on merit observing the Reservation Rules as per G.O.(P) 208/66/Edn. Dated 02-05-1966, G.O.(M.S)95/08/SCSTDD dated 06-10-2008 and as modified from time to time by the Government. Balance 50% of seats will be filled by the Management from the Management Merit List published based on Marks, GATE Score, experience etc.

Scholarships

Scholarship is available for candidates with valid GATE Score at the rate of Rs. 12,000/- per month vide G.O. (Rt) No. 67/09/H.Edn dated: 19.01.09 for the total period of 24 months subject to the following conditions.

a) Each student shall undertake 8 to 10 hours of work per week related to teaching and research activities as assigned by the institutions.

b) The students must secure first class or equivalent during the first Semester examination to become eligible for continuance of scholarship.

c) The student shall give an undertaking to the effect that he/she will not leave the course midway or appear for any competent Examination not related to Engineering and Technology.

d) The students shall not receive any emoluments, salary, stipend etc. from any other source during the course of study.

Any other details not specifically covered by the clauses given above will be decided by the Principal and his decision will be final and also he is empowered to cancel any admission which is found to be illegal.

Saintgits Merit Scholarship from Saintgits Management is available for M Tech students based on their B Tech CGPA. Fixed numbers of scholarships are allotted to each M Tech programme. Details are updated on the website.
